

MARMION ANGLING & AQUATIC CLUB Private Function Terms & Conditions

Please read these important conditions relating to private party bookings in the Bluewater Room or Restaurant as a private function.

These conditions are designed to protect the club and members in general and failure to abide by them could possibly result in permanent cancellation of your membership or sponsors membership.

Alcohol Management

As a responsible server of alcohol, a substantial cocktail menu must be supplied at any function where alcoholic beverages are being provided.

The MAAC as a responsible purveyor of alcohol has the right to refuse service of alcohol to any person, including private function guests. Under no circumstances may a minor consume alcoholic beverages on licensed premises. All laws relating to the "Liquor Act" must be adhered to.

Only beverages indicated on the function beverage list will be available for your function. Some negotiation can be made for additional packaged beers or premixes not listed however changes to tap beers will not be negotiable.

Guest will not be, permitted to bring alcoholic or non alcoholic beverages on to our premises for consumption under any circumstance, should this be brought to your attention on the night and ignored, the supervisor has the power to close the bar and terminate the function.

Beverage Tab

You are welcome to increase you beverage tab on the night providing your guests are behaving in a suitable manner and that any increase to that tab is paid on the night at completion of the function. **(No function can operate cash bar only).**

Smoking

The MAAC is a non smoking Venue, smoking is only permitted on the balcony and as per directions indicated.

Catering Policy

Food from outside can not be brought onto our premises with the exception of a symbolic style cake.

Children over the age of 12 years will be charged as adults.

Final catering numbers and payment for the menu and bar tab will be required **3 days** prior to the function, unfortunately, no refund is available for late cancellations on attendance. Numbers may be increased by up to 10% three days prior to your function and you will be charged accordingly.

Cancellation Notice

6 to12 months full refund, 3 to 5 months, \$45.00 retained for admin, balance refunded. Less than three months refund will not be available,unless the venue is re sold. A \$45.00 admin fee will be retained regardless.

Entertainment

You are most welcome to choose your own entertainment, however, should you need any advice we would be happy to assist. Please note strippers or similar performers are not allowed.

Decorations

The function room can be decorated to your personalised colour scheme or theme. Please note that nothing is to be nailed, screwed, stapled or adhered to any wall, door or surface of the building. The function co-ordinator must approve all signage in public areas.

Damages

The Club is always careful when looking after people & their belongings, however, we cannot take responsibility for damage or loss of merchandise left on the premises, prior to, during or after the function. Unfortunately accidents do happen and we must specify that any unnecessary damage to the Function Centre property during an event becomes the financial responsibility of the organizer.
